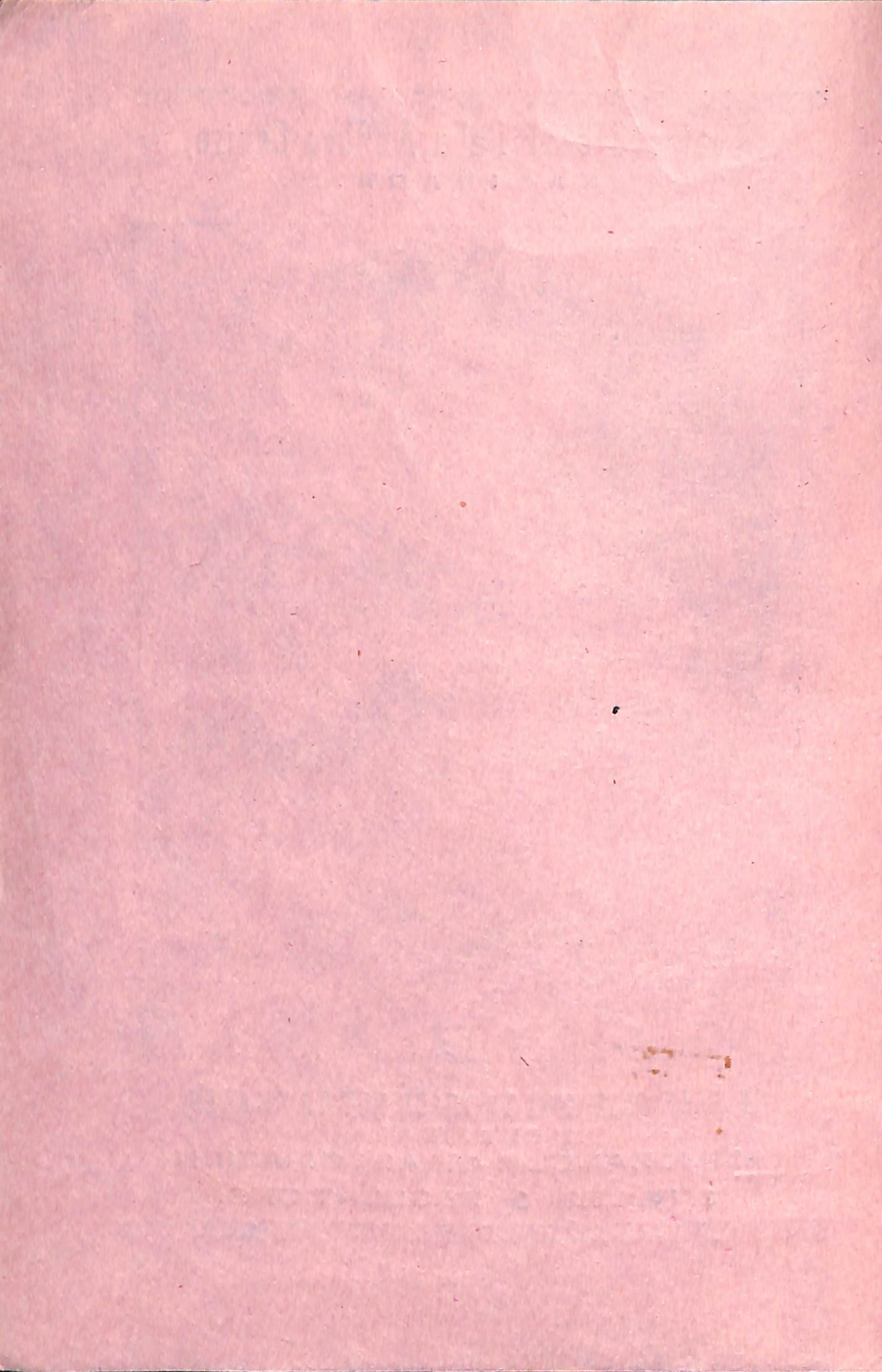

1. The name of the association is "Avatar Meher Baba Andhra Centre" Kakinada.
2. The area of operation shall be the geographical unit of the entire state of Andhra Pradesh.
3. The Head Quarters of the Centre shall be at Kakinada in the State of Andhra Pradesh; until otherwise decided by the Governing Body.
4. The objects for which the Centre is established are :
  - (i) To disseminate Avatar Meher Baba's message of Truth and Love by
    - a. publishing spiritual literature and journals in Telugu, English, Hindi and other languages,
    - b. establishing and maintaining libraries containing spiritual literature of Meher Baba for the use and benefit of the public, and

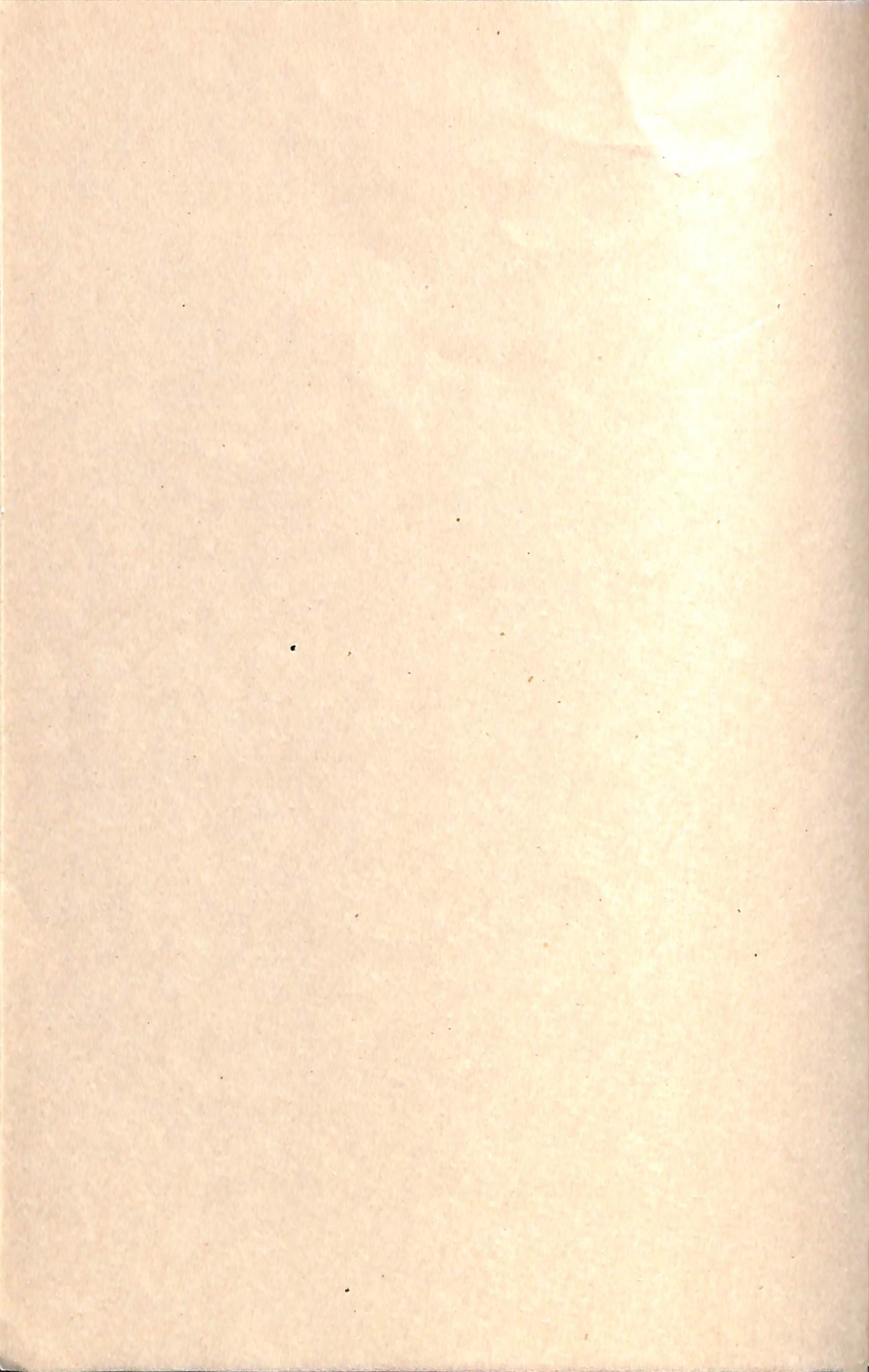

# Avatar Meher Baba Andhra Centre, Kakinada.

Rules and Regulations for the management  
of the Association.

## 1. MEMBERSHIP.

A. Eligibility :— Any person, irrespective of religion, caste, creed, nationality and sex.

- i. Who is not less than 18 years of age,
  - ii. Who accepts the objects, rules and regulations of the Centre,
  - iii. And who pays a membership fee of not less than Rs. 3/- per annum,
- can become a member of the Avatar Meher Baba Andhra Centre.

B. Admission :— The right of admission of an individual to the membership of the Centre shall vest in the Executive Committee

C. Any local Meher Centre in Andhra Pradesh can be admitted as a member on payment of an affiliation fee of Rs. 5/- per annum. Such Centre can send a representative to the General Body of this Centre.

D. The General Body shall consist of :

- a. all members of the Governing Body.

- b. all individual members, and
- c. all representatives of the affiliated Centres

E. The General Body shall meet at least once a year generally in the month of February.

## 2. GOVERNING BODY

i. The Centre shall comprise a permanent body known as the Governing Body of 51 members for the present, consisting of 1 President, 2 Vice Presidents, 1 Secretary - cum - Treasurer, 2 Joint Secretaries and 45 other members.

ii. The Governing Body is competent to fill up the remaining places, and any vacancies that may hereafter arise, from the General Body, whenever it deems necessary.

iii. A vacancy in the membership of the Governing Body shall arise in the event of one's demise, resignation, or absence from 4 consecutive meetings of the Governing Body. It shall, however, be open to the Governing Body to restore the membership of the category last mentioned.

iv. The President shall be elected by the Governing Body every year.

v. All correspondence on behalf of the Centre shall be carried on in the name of the Secretary and all moneys payable and due to the





Centre shall be paid to the Secretary. The receipt given by the Secretary shall be sufficient discharge for the same.

vi. The President of the Centre shall preside over all the meetings of the General Body, the Governing Body and the Executive Committee. In the absence of the President the Vice President, or in his absence, any one from among themselves shall preside.

### 3 EXECUTIVE COMMITTEE.

There shall be an Executive Committee to carry out the work of the Centre from time to time. It shall consist of eleven members including the President and Office bearers. The President shall nominate the office bearers and other members of the committee every year.

### 4 MEETINGS OF THE CENTRE.

i. An annual Governing Body meeting shall be held every year generally in the month of February to receive and consider the balance sheet, receipts, disbursements, accounts, budget, and report presented by the Secretary to the Executive Committee and approved by it.

ii. A special Governing Body meeting of the Centre may be held as and when required or when requested for in writing by not less than 15 of its members.

iii. A meeting of the Executive Committee shall be held at least once in a month or oftner when found necessary.

iv. A notice of every meeting shall be given by the Secretary specifying the venue, day, and hour along with the agenda of the meeting generally 15 days in advance in the case of the annual or special meeting of the Governing Body and 8 days with regard to the meeting of Executive Committee.

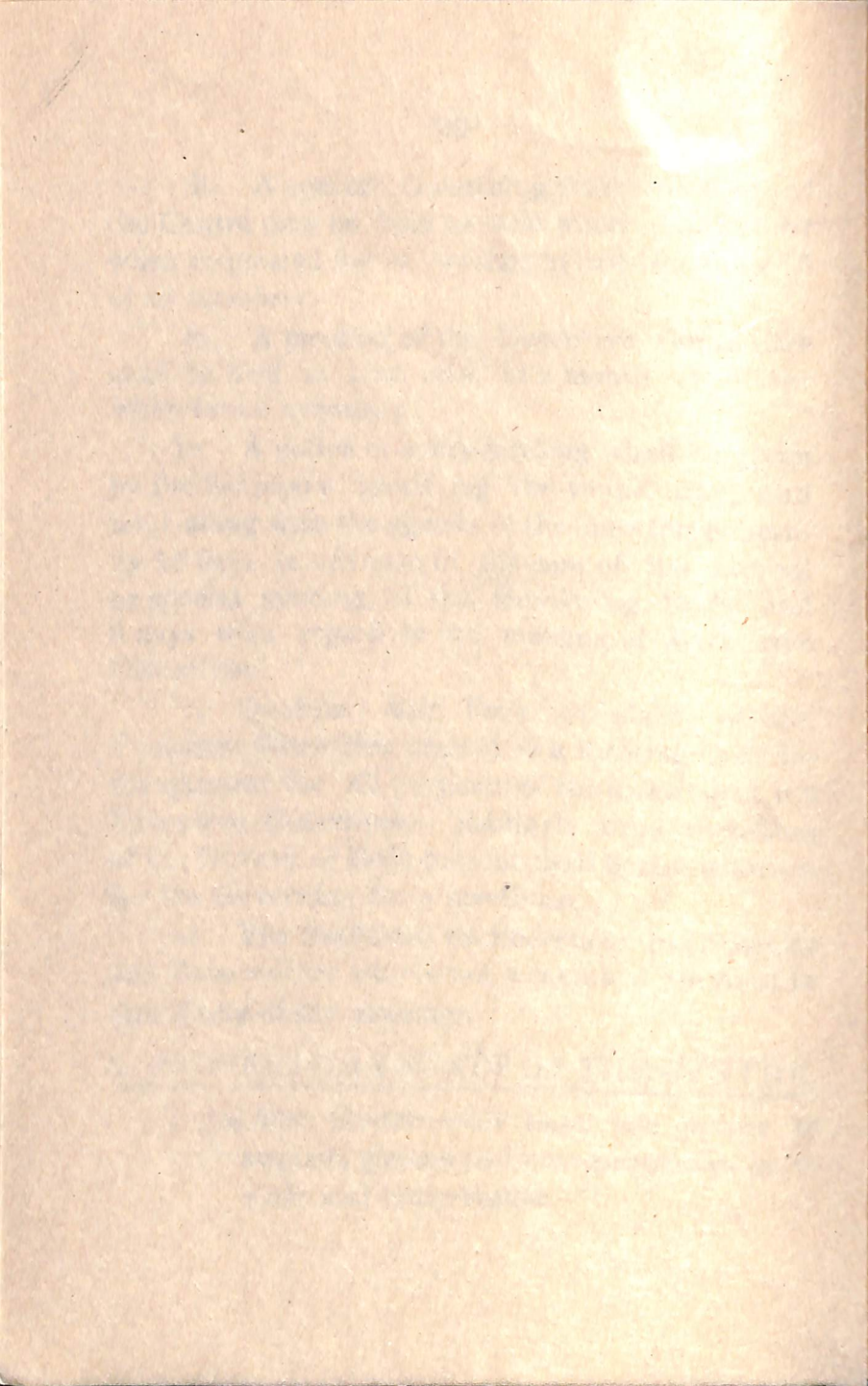
v. Quorum : Any Four members of the Executive Committee present in a meeting shall be the quorum for all purposes of the meeting of the Executive Committee. Similarly nine members of the Governing Body present shall be the quorum for the Governing Body meetings.

vi The President or Secretary may invite any Baba-worker who is not a member thereof to attend any of the meetings.

## 5. PROPERTIES & FUNDS OF THE CENTRE

I (a) The Centre shall have the power to acquire, possess and own properties moveable and immoveable





- (b) The Centre shall receive, collect, hold and manage funds raised for and belonging to the Centre from any source.
- II. The main sources of income shall consists of donations and annual fees payable by individuals and Centres.
- III. The funds of the Centre shall be kept in a Scheduled Bank as may be resolved by the Executive Committee and the said account shall be operated upon by the Treasurer jointly with President or the Secretary.
- IV. All funds and the property of the Centre shall be held in the name of the Centre. All rights of property of the Centra shall vest in the Governing Body.
6. The Centre shall sue and and by sued in the name of the Secretary.
7. Books, Accounts, and Documents etc :—
- i. The calendar year from January to December shall be the year for the purpose of accounts for the Centre.
  - ii. The accounts of the Contre shall be duly audited every year.
3. Power of modification :
- i. And addition, alteration or omission in these rules shall be effected by a resolution passed by the Governing Body by

two thirds of the members attending the meeting. at a meeting of the Governing Body specially convened for the purpose.

- ii. The Executive Committee may make rules not inconsistent with any of the rules for the management of the affairs of the Centre.

#### 9. Dissolution :

On dissolution of the Centre, the action of the Centre shall be subject to the provisions contained in Sections 12 to 14 of the Societies Registration Act, Act XXI of 1860.

10. There is no business intention in forming the Association.
